- 1- Name of the Society "Ram Ji Lal Memorial Education & Social Welfare Society Mandnaka"
- 2- Registered Office Vill.- Mandnaka The- Hathin Distt. Palwal
- 3- Area of Operation All Haryana
- 4- Aims and Objects:
 - a) To open/ start educational institutions like schools, colleges, technical and medical institute and to start different coaching centres for competitive exams.
 - b) To start/ run/ open coaching classes of English spoken and differen Languages.
 - c) To start computer centers, cyber cafes, NIT centers, different courses of fashion designing, web designing and other activities to develop personality of young boys and girls.
 - d) To help those young students who are enable to get higher education due to one or other reasons by giving them education according to their efficiency.
 - e) This organization will utilize its funds for the promotions and benefits of the down trodden people and for the charitable hospitals, blood bank, free health check up camps and for the promotion and family welfare scheme and this organisation shall at no profit basis which is main and foremost object of this organisation.
 - f) To promote cultural, social and educational activities and to help in collating the moral values among boys and girls and to impart various activities for rural development.
 - g) To undertake other educational programmes, to ensure inegrated development of personality by boys and girls giving more emphasis on moral values/ ethics.
 - h) To do such cultural actiyities, organise debates etc, celebrate Annual and National functions so that the students may become good citizens of India.
 - i) To set up Educational Institutions on modern lines in consonance with the norms and ideals and cater to the academic, cultural, physical, moral, emotional and intellectual needs of boys and girls.
 - j) To give and to seek assistance from registered society;s, societies relief funds or other bodies for furthering the objectives of the Society or at the time of natural calamities for organizing relief work. By organizing relief team, sending volunteers, collecting donations, medicines, clothes, food grains etc and disbursing the same to the victims of the calamity.
 - k) To do all such other lawful activities as the Society considers conducive to the attainment of all or any of the above objectives.
- 5- Conditions:
 - a) The income and property of the Society shall be applied Solely towards the promotion of the objectives of the society as set forth in the Memorangum of Society and no portion there of shall be paid or transterred directly or

indirectly by way of dividend, bonus or otherwise by way of profit, to the members of the society.

- f) No member of the society shall be appointed to any salaried office of the society or any office of the society paid by fees that no remuneration shall be given by the society to any member of such Governing Body except repayment of out of pocket expenses and interest on money, lent or rent for premises of the society.
- g) The society by its constitution is required to apply its profits, if any, or other income in promoting its objects.
- h) If upon the winding up or dissolution of the society there remains after satisfaction of all its debts and liabilities, any property whatsoever, the same shall not be paid to or distributed among the members of the society, but shall be given or transferred to some other Institution having objects similar to the objects of the society to be determined by the members of the society at or before the time of dissolution.
